Respected Sir /s.

I am a highly qualified and responsible citizen of India, being a professional individual engaged in Aadhaar project and I want to share most confidential and serious aspect of Data quality and Integrity of Aadhaar and UIDAI. I am conveying you, based on proper evidence, facts, figures and ways to get evidence [by scrutinizing and holding UIDAI officials responsible for doing massive frauds and committing errors in data , doing crimes to drive a dud placebo called Aadhaar. The Government of India and its agency UIDAI has till now mislead Supreme court and Nation by showing that everything is fine whereas actually the entire data set has 40% Bogus data, fabricated facts. UIDAI CEO is bent upon misleading whole nation through articles in media, ncorrect data, events, articles in newspapers by UIDAI head, TV interviews about Aadhaar, its features, security etc.

I am sending you the genuine, **verifiable, classified, authentic, scientific, Data and fact-based** and most confidential communication to bring home very critical point dealing with our beloved country, where very basis of our constitutional rights are at risk and bound to be endangered by top level politicians, bureaucrats and private companies to impose, unimaginable pains, victimization, denial of human rights as historical yoke on innocent citizens of India. The Bio-metric approach was totally unnecessary, while clear methodical systems are available to prepare individual Identity card of a person, using fool-proof techniques on Card itself : Examples : Social security number of USA.

Background

Supreme court has been epitome of all such anomalies, practices, criminal offences, which are most clandestinely proposed by people who have diabolical self-interests to destroy fabric of democracy. Such people will wear garb of saints but actually practice all such dangerous ploys, tools, steps at Macro level to cause doom, and all these tools are used mercilessly, as weapon to torture innocent and honest people [who they feel enemies of their party].

Most unfortunate part is that, The politicians and bureaucrats are cunningly trying to portray Aadhaar as only tool to handle complex issues faced by country and bent upon passing on the dangerous tool of Aadhaar as if it is only medicine to all evils in country. They are pushing Aadhaar as portent tool, thru neck of country with Bogus data, incorrect bio-metrics, unproven technology, in garb of homegrown technology, with sole vested interest of securing favour from poor voters, using subsidy, bank accounts linking with aadhaar and in this process gain voters favour [Illegal persons get Aadhaar card and get license to avail all kinds of other benefits].

Everyone knows that India is backward country without much resources, without any global bio-metric benchmark or standard for consideration to implement such crucial system, where no country in whole world has thought of even venturing in Bio-metric systems for such a large population.

There was no need at all to drive whole nation go after Aadhaar while this is indigenous, self- declared solution on major assumption that Bio-metric is unique. However its proven beyond doubt that the bio-metric also keeps on changing in a person and that's why No developed nation in world, ventured in this non-established route to deploy among billions of people for such a sensitive activity of Financial management or government to citizen services function as tool of identity. There can be hundreds of options to pilferage using bogus data in Aadhaar, hundreds of ways to victimize a society, race, religion, person, even if a secured repository is made sure. **Creating bogus record based system is one thing and securing crap data is another thing.**

Now biggest flaw in the system is that UIDAI has not followed standard and legitimate process to enrol records and has dubiously collected these data repository for 115 Crores in a proper, legitimate, secured, complied manner therefore more than appx. 40% Records of population has already entered in Aadhaar system, without basic statutory requirement of taking information through verified registration form, proof of identity and proof of address. Till now UIDAI has been intentionally hiding such grave blunder of pushing wrong data for aadhaar generation and blowing trumpet of doing

something great, by putting misleading articles of praise about Aadhaar through Government officials / ministers in Media.

Please note that, UIDAI is doing all kinds of misinformation thru media to promote Aadhaar and not talking anything about Bio-metric technology or bogus aadhaar records, or failure of aadhaar authentication activity, in system.

Whatever UIDAI is now producing as evidence is post-facto action as eye-wash and if SC will go in detail, it will find out real worms inside Aadhaar system. The Data capture system had been rampantly compromised and UIDAI is prime accused to firstly commit bungling and secondly hiding fact of bogus records till now , even after 6 years of operations.

If today SC demands complete data pertaining to 115 Crore records under Aadhaar, UIDAI will be able to hand-over only 61% data with their supporting records. [please refer Annexure – A] . It is to be noted that in absence of actual statutory, mandatory application form of aadhaar enrolment and its proof documents, which was a mandatory and legal requirement of process, and without these basic forms, proofs, entire record of Aadhaar becomes null and bogus.

Also, please note that UIDAI has already processed these, bogus records and issued Aadhaar numbers which is a national level risk, fraud and highly objectionable act committed by UIDAI. [SC can verify this allegation through comprehensive Audit, as UIDAI itself had issued letters to agencies to provide all records showing absence of all these documents for more than 40% cases].

Today UIDAI is trying to remain silent about such a massive goof-up and blunder lying within the Aadhaar system, and showing to Supreme court and world that everything is fine. They have thrown appx 1.0 lakh enrolment operators on road to die and now as eye-wash, pushing hard to involve desperately all banks and Government departments at war footing. Their junior and senior officials are taking bribes to allow Aadhaar enrolment operations at a place without any rule or regulations. Just recently they are adamant to put machines at banks [After SC indicted them about Data secrecy]. They have created such a corruption prone web of system, where poor public is bound to pay between Rs 100/- to Rs 1000/- per aadhaar enrolment from so called enrolment centers set up through spurious private agencies / street shops working under camouflage of govt agency namely [CSC , Mahaonline, DOIT etc].

Data secrecy can be applied on proper and bonafide records, but while 40% records are bogus in the system itself, what kind of secrecy shall be applied. UIDAI is good in managing bogus data sets and very good in making fool to whole world about biggest frauds caused through dubious and unproven technology [Bio-metrics and iris scanning]. This is best example how to make billions fool with eyes open, through all kinds of tricks, technical jargons and legal wrangles.

The mandarins sitting in UIDAI have acted like maniacs and dictators just to prove their point of pushing poisonous Aadhaar in throat of innocent citizens of India. Today frankly speaking, all administrative quacks are sitting at UIDAI [headed by biggest moron named as CEO, who has zero technical knowledge, qualification experience]. Majority

of ADGs/ DDGs are pulled from sick Government units : MTNL / planning departments / BSNL / DOT as punishment posting who simply push dictums of Head Office's office memorandum, as senior clerks.

In such a scenario, I must bring out most confidential matter and key aspects dealing with Aadhaar's bogus records, so that at this crucial juncture, Supreme court of India takes a call, verifies what I am saying, and only after finding correctness of my allegations, decide about Aadhaar.

You will be able to comprehend internecine ploy being implemented by current government also, which wants to take up Aadhaar as their channel to appease poor voters for their vested interests, without caring about legal aspects, rationale or ramifications. Objective can be anything, i.e. to appease illegal voters, to benefit illegal persons, to remain in power as Aadhaar can act as platform ID for all other IDs.

Before elections, the current PM was launching scathing attacks, on Aadhaar then after getting elected, the cunning PM realised key attributes of aadhaar and planned huge efforts to first open zero balance bank accounts and then linking with aadhaar so that Government may misuse the channel to push money to bogus, poor people s accounts as subsidies and get confidence of gullible voters.

In this garb, Government will like to project social welfare aspects and growth parameters, but actual aim is to garner vote banks only.

And There have been multiple meetings between CEO – UIDAI and political brass of government to put every effort to get Aadhaar channel in place and obviously they will not mind to befool judiciary, public at large and crush any protest, basis or law, using all kinds of tactics to prove their point and run away with the dangerous plan of Aadhaar.

There are so many questions which must be asked from UIDAI and then decision must be taken as per course of Law to book culprits and bury such a fraudulent Aadhaar system.

Let us ask simple query, how can a technology system be successful when, its totally unproven in world at this scale of deployment, where are real-life audits, benchmarks, what about any pilot outcome, where are similar instances in whole world, whether data to capture records is legally done, properly recorded, as per legitimate processes, whether data capture is as per legal method, whether source data is verifiable, with mandatory and proper application form, supporting proof of identity, address. What is the real scenario where 30% person's aadhaar bio-metrics are failing in rural / semi-urban locations, so where is accuracy gone.

SC will find ultimately that all these questions are unanswered because, Aadhaar is untested technology, unproven, without benchmark, so-called home grown, without any approved pilot and a project imposed by a technology guy, who never bothered how the legally each component will be handled. Just by saying Aadhaar is homegrown technology , does not serve purpose because, Aadhaar itself has no proper aadhaar.

Congress Government initiated and BJP has implemented and UIDAI have pushed enrolment agencies to deploy exorbitantly costly machines in 2011, asked them to deploy lakhs of machines were deployed during 2011 to 2017. These machines required trained manpower so manpower costs, salaries for 6 years for 2 lakh operators, this has been incurred by companies in thousands of crores. UIDAI did not issue aadhaar cards to 115 crores and only 40 to 50% people received cards.

There have been massive frauds committed by intentional ploy, of indirect recommendations of machine models for Biometrics, iris scanners, GPS trackers, list is long. Since beginning UIDAI has taken route of not selling Hardware and made industry to buy equipments from market, [another way to bring in corruption by recommending limited devices or device of choice]

More than Rs. 10,000 Crores have been already spent to put something which is totally full of bogus records.

No Global Precedence of Biometrics use at Mass scale Deployment

None of Developed nations have ever thought about pursuing or considering bio-metric identification, as its totally flawed and it is wild goose chase as even finger prints keep on changing for a person, there is no technology to define uniqueness of a person. There is no technical trial of this kind of technology at all in whole world, or even in India, there are no precedence of any such large scale deployment to address identity in whole world.

Everyone knows, India is a backward country and like any third world republic imposing Bio-metric system, without any scientific, technical or factual basis. It is intently made to presumed, that Aadhaar is best. Whereas, if any type of smart Card could provide even better outcome at very low cost and risk, if prevalent cards are designed and developed properly, [PAN Card, Election card] it is definitely going to result in more robust system for providing identity, without Aadhaar.

Answer lies in basic questions, Why Aadhaar, Why not any other simple Card which has systematic, demographic and digitally processed card, can be brought by Government. Even a person's name, father's name, date of birth, and physical recognition mark, all combined will be able to generate unique numerical ID of a person. Only focus is to be ensured that card must be non-repudiable.

Shocking aspect is that, UIDAI [apex body to manage Aadhaar] is trying its best to submit all clear and beautiful stacks of government documentation, to apex court thinking that Supreme court deals with legal aspects only and they will never come to know truth about technicalities or data related issues.

LET ME PUT IT SIMPLY THAT, UIDAI HAS DONE THE DATA COLLECTION ACTIVITY IN MOST ABSURD, UNCONTROLLED, ILLEGAL AND CRIMINAL WAY, WHERE ALMOST 40% OF DATA CAPTURED ARE PUSHED IN SYSTEM, WITHOUT ANY PROOF OF APPLICATION FORM OR STATUTORY DOCUMENT TO SUPPORT, A PERSON'S IDENTITY.

I AM CORRECT, 40% OF DATA i.e. appx 45 Crore DATA IS JUST BOGUS AND ABSURD, WHOSE AADHAAR NUMBERS HAVE BEEN ALREADY ISSUED.

UIDAI HAS COMPROMISED, VERY FUNDAMENTAL PROCESS OF SUBMISSION OF APPLICATION FORM FROM A RESIDENT, WHERE IT WAS MANDATORY TO SUBMIT APPLICATION FORM WITH MANDATORY PROCESS OF KEEPING SUPPORTING DOCUMENT AND AFTER PROPER VERIFICATION ONLY, BIOMETRIC AND IRIS CAPTURE SHOULD HAVE BEEN DONE.

- **There are no Application Forms with UIDAI for 45 Crore Residents [If UIDAI disagrees, SC Must ask to submit complete list of 115 Crore Application Forms.**
- **There are no Supporting Documents of 45 Crore residents [Who have been issued Aadhaar Number [If UIDAI disagrees, SC Must demand complete list of 115 Crore Members Supporting Documents]**
- **UIDAI had made it mandatory process to verify every application form by a duly authorized person, called as verifier but only 5% residents application forms were subjected through verifier, hence 95% Data is erroneous and illegal as it was not captured based on correct and valid documents.**

BUT MOST SHOCKING REVELATION AND TRUTH IS THAT THERE IS NEITHER ANY SIGNED APPLICATION FORM FROM A PERSON, NOR ANY SUPPORTING DOCUMENT OF MORE THAN 40% POPULATION, WITH THESE CORRUPT, NEGLIGENT, CONNIVING UIDAI OFFICIALS. [Please refer Anexure A, which is record handed over by UIDAI s agency , namely HPE [Hewlett packard Enterprise], which manages Document Management for Aadhaar Records].

I AM WELL AWARE, WHAT I AM TALKING ABOUT AND SUPREME COURT MUST DEMAND APPLICATION FORMS AND SUPPORTING DOCUMENTS OF ALL AADHAAR RECORDS, AND FOR UIDAI IT IS IMPOSSIBLE TO PRODUCE FOR MORE THAN 40% PERSONS OF INDIA, BECAUSE THE DOCUMENTS WERE NEVER RECEIVED AND BASIC LEGAL PROCESSES WERE FLOUTED, DATA WAS ALREADY COMPROMISED, DATA WAS CORRUPTED AND DATA IS CORRUPT ALREADY NOW. ENTIRE DATA CAPTURE ACTIVITY WAS A RESULT OF RAMPANT METHODS USED BY UIDAI WHERE NIL CONTROL OR PROCESS COMPLIANCE WAS MOOTED OR IMPLEMENTED BY CORRUPT AND RECKLESS UIDAI.

IMAGINE NOW THEY ARE ASKING SUCH BASELESS AND CRAP DATA TO GET LINKED WITH PAN CARDS / TELEPHONE NUMBERS / BANK ACCOUNTS / PAYABLES OF BENEFITS / PDS / TRANSPORTATION, AND WHAT KIND OF DANGER COUNTRY IS PUSHED INTO.

UIDAI DOES NOT HAVE SINGLE APPLICATION FORM AND SUPPORTING DOCUMENT OF MORE THAN 45 CRORE PERSONS, 40% PERSONS IN INDIA, WHOSE AADHAAR RECORDS ARE PROUDLY KEPT BY UIDAI, AND FOR WHOM THESE AADHAAR'S WERE GENERATED DID NOT CARRY ANY PROOF OF IDENTITY. THIS BLUNDER HAS BEEN HIDDEN FROM EYES OF WORLD AND SC BY UIDAI.

UIDAI IS INTENTIONALLY HIDING THIS FACT FROM SUPREME COURT AND WHOLE WORLD ABOUT SPURIOUS SOURCE OF AADHAAR RECORD AS UIDAI DOES NOT HAVE ANY SUCH BASIC RECORD AND MASSIVE FRAUD OF USING SCRUPULOUS RECORDS HAVE BEEN MADE BY THESE INEFFICIENT SET OF JOKERS AND CRIMINALS.

WHILE THERE IS NO IDENTITY DOCUMENT WITH UIDAI, HOW CAN AN AADHAAR NUMBER BE PROCESSED, WITHOUT MANDATORY PROCESS OF REFERRING TO SIGNED APPLICATION FORM AND SUPPORTING PROOF OF DOCUMENTS OF POI [Proof of Identity] and POA [Proof of Address].

THE PROCESS WAS MANDATORILY DEFINED BY UIDAI TO GET FILLED UP APPLICATION FORM WITH SUPPORTING PROOF OF IDENTITY AND PROOF OF ADDRESS. BUT THESE BASIC LEGAL PROCESSES OF RECORDS / DOCUMENTS WERE NOT USED AND THERE WERE NO VERIFIER IN REAL ENROLLMENT [Proof is that 95% records, applications forms wont have any signature of verifier].

AFTER ENTRY OF PERSONAL INFORMATION BIO-METRICS AND IRIS BIOMETRIC WAS SUPPOSED TO BE PERFORMED. POST THIS ACTIVITY, THE DATA WAS SUPPOSED TO BE SENT TO UIDAI FOR VERIFICATION OF APPLICATION, VERIFICATION OF PROOF OF IDENTITY AND ADDRESS AND THEREAFTER PROCESS COMPLETE DATA AND GENERATE AADHAAR NUMBER. HOWEVER THE PROCESS OF AADHAAR GENERATION WAS COMPROMISED AND AADHAAR NUMBERS WERE GENERATED WITHOUT ANY KIND OF VALIDATION AND VERIFICATION ACTIVITY, WITHOUT ANY KIND OF DOCUMENT.

IF THERE ARE NO APPLICATION FORM ITSELF OR SUPPORTING DOCUMENTS OF MORE THAN 45 Crore PERSONS, OR NIL VERIFICATION THEN, ON WHAT BASIS UIDAI HAD GENERATED ADHAAR NUMBER AND THEREFORE HOW UIDAI

IS ALLOWED TO WORK AT ALL AND WHAT IS BASIS TO GENERATE AADHAAR NUMBER BECAUSE PERSON HIMSELF IS NOT VERIFIED OR BONAFIDE.

DUE TO SUCH HUGE LAPSE, UIDAI HAS VIOLATED BASIC LEGAL NORM AND PROCESS OF AADHAAR ENROLMENT AND PUT HUGE NATIONAL RISK FOR COUNTRY, THERE UIDAI MUST BE DISMANTLED IMMEDIATELY, FOR WASTING COUNTRY'S PRECIOUS LIMITED RESOURCES OF FINANCIALS AND WORK BLINDLY TO DERIVE VESTED INTEREST.

SC has always intervened and taken calls, to rectify and throw away any such Wild and Internecine impositions committed by bureaucrats and politicians for vested interests, by passing on historical verdict to make sure continuation of all socio-economic standards and benefit common man, and passed order about right to privacy. However it has left gaping black hole by giving room to hyenas and vultures, who look like humans but actually do most unimaginable acts to masses, for reasons of corruption and internecine aspects of controlling data and playing with lives of law abiding citizens.

I want to request you with folded hands that please never trust on what quantum of documents UIDAI team is submitting, as they somehow want to push Aadhaar as it has long term panacea, or strategy to get vested interests addressed for their combined milking of people of India.

Now, taking advantage of leverage given by SC to Government to safeguard sensitive data from misuse, UIDAI and GOI are trying their best to present their case in gold covered papers, which is nothing but poison, cow dung or gutter mud. UIDAI will never commit hara-kiri by saying that the 45 crore records have been wrongly pushed in system.

Data is already compromised as UIDAI has issued 45 Crore bogus records and its fact that they can never submit these bogus records whose aadhaar numbers are generated. Of-course UIDAI will be able to submit partial records only for 68- 70 Crore records only.

If SC gets confused by wrong affidavits, loads of crap papers and words, humanity in India will be at risk of sufferings at the hands of vultures to rule. So please read these articulations and then take strongest possible action in terms of verifying what is being conveyed here.

Whether my allegations are true or not, can be assessed only after proper scientific analysis and verification of facts which are presented as eye-opener and demanding all relevant documents will open this mega fraud already committed and still happening in India.

I am highly reputed individual who knows what is being conveyed here and why it is of paramount interest to nation to bring out truth for betterment of system. But to save myself from dangers and risks under present regime, I Don't want to come forward openly, with my name on Open forum to save my skin and life.

We must be careful of any single action , which may darken fabric of democracy and may cause irreparable damage.

Supreme Court is being misguided by UIDAI brass [Its CEO A B Pandey is Corrupt, ignorant, cunning Puppet and Sycophant of current PM and current politicians at Central Government and the talkative fellow has taken so many illegal and wild decisions for his vested Interest against Government Financial Rules violating majorly in Financial penal actions and imposing arbitrary terms of engage of services with partners]

My brief letter is being sent to you to give you information about basic weapon to deal with one such introduction called as Aadhaar. Govt had deliberately supported and pursued the programme, illegally, without giving proper thought process, without any pilot programme, without following legally correct basic information gathering exercise and flouting all kinds of defined processes causing immensely detrimental and most dangerous situation, where anything and absolutely anything will happen, in addition to loss to exchequer of Government.

Right to privacy deals with key aspect to practice any such proposition, where honorable SC has cautioned to use Aadhaar, after ensuring proper safeguard, from data leakages, data misuses, data infringements. When Data itself is corrupt and developed without mandatory and statutory process of having each application form signed and supported with proof of a person's Identity.

SC should also have demanded bonafide and proper documents to allow such kind of technology trick [Bio-metric] to be pushed for large scale implementation. By targeting just data secrecy, SC assumed that Aadhaar technology is acceptable, which is highly fallacious. In addition of technology non-substantiation, additional introduction of riding on bogus records, what kind of service enabling would take shape, only god knows.

It is insufficient on part of SC, which says that , fine pls do robbery but don't hurt or kill anyone, Pls do small thefts but don't commit murders. By allowing with safeguard, SC means to convey that , When you commit murder, remove all proofs or wear proper gloves so that murder is not seen or known to anyone.

SC Must never give even smallest of elbow room to Government and UIDAI, which would remain saintly for sometime and then take its plan at work by selectively condemning individuals to hell using the aadhaar tool. In real they are murderers of truth, law of land and highly dangerous people, who want to get hold of real power using whatever method, legal or illegal, right or wrong.

Kindly note that if UIDAI is trying to mislead you that now all enrolment centers are under Banks or Government Premises , it's a total lie because already 115 Crore Enrolments are already done and they are referring to current measures as eye-wash.

Please remember, more than 115 Crore of enrolments have been done by only privately owned systems.

SC Must flog and castrate CEO UIDAI for misleading nation as already 45 Crore records are bogus. Proof lies in actual records, so please demand complete 115 Crore

resident's application form, their supporting proof of identity and proof of address, which are mainstay and basic legal precincts to proceed a verified set of data and get aadhaar number registration activity. CEO UIDAI will be dirty in pants because there are actually no record, 40% data is bogus, 95% data has been pushed unverified [which was mandatory process so stands process non-compliance and major error].

I am sorry to point out that all the fears of SC cannot be ensured by UIDAI , which is headed by scrupulous elements who are just pleasing their Bosses at Government and doing all kinds of compromises with the aadhaar system and bogus data. SC must act extremely wisely, smartly and must be driven by facts, actual verifiable records.

A. Aadhaar is most dangerous tool, having subjectivity to compromise Right to Privacy

When Hon'ble SC is recognising right to Privacy as fundamental right, how can a faulty, erroneous and potentially dangerous tool like Aadhaar is being even considered by SC to go-ahead subject to precautions of data security, ensuring data leakages etc etc. leakage comes up later, first is data quality because when 40% data is without any application form, proof of supporting documents, how can a system be used at all. Aadhaar numbers to 45 Crore bogus persons are already generated and issued.

If a tool is known that it carries risk, and it is being considered with subjectivity, it is all the more risky to permit at all and proper thought must be given by SC to dissociate any such tool, which may cause damage to society / individual / entity.

Example :

Suppose SC allows using Aadhaar number for basic utilities of Financial system, identity system, grant of financials to people of India and tomorrow, same government changes its base-line thought to victimize an individual, entity, ethnic group due to whatever reason of Political adversity, geo-graphical boundary, and are targeted for harassment or denial of basic public and financial services , it can be easily done by Government machinery by holding Aadhaar number at ransom by blocking the authentication itself.

These are something, which SC cannot stop from actually happening.

Government will submit 1000 pages undertaking that they have taken huge measures to safeguard data, but what if Government itself becomes hyena and utilizes the data against their targeted enemies.

I repeat to tell that, UIDAI AND GOVERNMENT ARE HIDING FACT THAT ENTIRE AADHAAR DATA IS BOGUS, AS 45 Crore RECORDS IN CURRENT SYSTEM IS GENERATED WITHOUT SIGNED APPLICATION FORM AND VERIFIED SUPPORTING PROOF OF IDENTITY [Which was mandatory to be referred prior to making Aadhaar Enrolment followed by Aadhaar number].

Can anyone stop this including honourable Supreme Court. So If something bogus like Aadhaar, which is built on bogus data, is imposed on Public and Country as a whole, the dangerous and wilful elements will be able to succeed in their clandestine designs. Supreme Court must analyse it very carefully knowing that these politicians and bureaucrats are menace to society at large and they can implement something mindlessly, to set right their dangerous agenda anyhow, today of tomorrow to appease population illegally and rule country through illegal means.

Nobody, except UIDAI, HP Enterprises and myself, know that there are NO records of application forms, proof of identity's supporting documents, for more than 45% aadhaar records. Real Shocker , but its as true as sun and Moon.

This is pure fact, based on data and internal information and letters about UIDAI s data keeping system. SC can easily conduct audit and verify itself , UIDAI does nt have any proof of records of 45% + persons , whose aadhaar numbers are issued, it directly means that illegal and bogus Aadhaars have already been issued.

Government had spent more than 10,000 Crores on the blind crocodile which is purely intended to capture every resident's co-ordinates so that Government knows pulse of its residents and may misuse the data according to its most heinous designs of victimisation. Government might use aadhaar channel to push thru illegal gratification to public by passing on some subsidies, in garb of social welfare & engineering.

These bureaucrats and politicians nexus can go to any depth of shamelessness by compromising all such acts, to institutionalize something so dangerously sensitive like Aadhaar, as tool to handle public grants, subsidies, votes.

Instead of strengthening and correcting basic systems of PAN Cards, Elections cards, Identity cards, they have gone ahead to put some quack's, highly risky proposition of non-existent authentication system [a report came in media that more than 28% bio-metric authentications are failed in real world in India] . This is verifiable input that majority of authentication gets failed due to poor data matching facility and incorrect data repository. SC must appoint some impartial agency to test % of Aadhaar authentication failures from PDS / pensions / mnrega beneficiaries in rural India. The mismatches are startling 28%.

Let SC order impartial field level authentication of randomly selected only 10,000 persons aadhaar [at ten different states] to match from rural India, who are also beneficiaries.

- A. Firstly UIDAI will fail to provide full record of these 10,000 persons as 40% records are bogus, but they have generated aadhaar numbers.**
- B. Secondly, UIDAI wont be able to match Finger bio-metrics of all 10,000 persons , which means that the Aadhaar bio-metric approach itself is faulty and dubious. Estimated 28% cases would surely fail authentication, so whom UIDAI and GOI are making fool.**

One can safely declare that Aadhaar is bogus as 45 Crore i.e. 40% data of entire population, itself is generated without statutory signed and verified application form of an applicant and also they are without proof of identity and address and not verified whether there is a person in that name or not, living at particular place or not.

It is matter of highest concern where, innocent public are being imposed with a technological blunder called Aadhaar, which has been developed, captured, stored without any source of proof of valid document of identity or residence. [I vouch that UIDAI has no document to provide for more than 45 Crore residents] and they are internecine and shamelessly hiding this major blunder and gaffe, carelessness and non-compliant state of affairs.

UIDAI CEO must be hanged to death for implementing such a key system with bogus data and playing with lives of billion plus people of India . On top of that CEO UIDAI is hiding this crucial fact from Honourable Supreme Court and has temerity to write heaps of praises about Aadhaar for false propaganda and remain seated as CEO for ten years to rule anarchy. If a record is being declared as bonafide record, so there has to be some application [signed and verified], with source of proof of a record / document which says that the person is ABC. Sadly there is no basis to prove , where UIDAI could say for sure that they have there is 100% supporting document availability. So entire UIDAI s aadhaar number is full of errors and where is base of UIDAI aadhaar data, while 40 Crores of records generated are bogus.

To support my claim, I am providing you summary data of bogus record count and UIDAI must be able to provide 115 Crore records of Aadhaar enrolment application forms , proof of identity in one week, and I am absolutely and 100% confident that they will never be able to do so. UIDAI will fail surely as there are no such proofs with these jokers.

Please sir, take most strictest action against CEO UIDAI and immediately dismantle UIDAI set-up, which is merely absurd and faulty and unnecessary activity.

Likewise, there are 45 Crore persons records whose no physical / scanned documents are with UIDAI and their data has been pushed in system, to create bogus record.

Only UIDAI and politicians know about devilish origin of Aadhaar. No such system exists in whole world even for 10 lakh population. There was no benchmark or pilot of this hoopla project. Bio-metrics keep on changing in a person every 5 year [Ageing parameter]. It is just a massive waste done to promote bio-metric companies and spend anyhow 2 Bn Rs. The data source was created by road side operators, where no verification was done from proof of identity / proof of address. [most risky source] There are more than 45 Crore persons entered coolly in data and got Aadhaar number, where there is no application form to apply for aadhaar, no verifier , no proof of identity, no proof of address. So entire repository cannot stand audit if Supreme court demands it. Now whatever UIDAI is doing , is merely eye-wash to shift enrolment centers in govt premises / banks , after creating 115 crore enrolments.

Truly and shockingly, only few people know [this fact that UIDAI does not possess any such statutory application form [signed and verified] document to validate the basis of a record and there are no proof of identity or proof of address.

It is only in papers, and interestingly, Government of India, themselves had laid down the process of retaining properly signed and verified application forms, proof of documents [POI and POA] but they short-changed the entire data capturing system and compromised at the cost of country-men s basic aadhaar number to allow corruption from all sides.

- A. Appx 115 Crore residents of country have been covered by UIDAI for Aadhaar, saying that it is important tool to recognize a person, through aadhaar number, but challenge of identification itself is wronged due to high level of mismatches even using Aadhaar Biometrics of a person. As per general finding and report appx 28% bio-metrics gets bounced during authentication [Reported on Media already by a petitioner]

As there is no benchmark of bio-metric system in whole world, there is no precedence of massive use of bio-metric data, and the technology itself is not technically proven. There is no audit of such a system, citing security reasons, No one questions UIDAI.

When Bio-metrics itself is under question, where is basis to declare Aadhaar itself a valid tool, instead of this, why like other most developed countries, our country also follows single , non duplicatable card and handles all kinds of authentication, instead of falling in trap of aadhar [bio-metric authentication].

- B. I HAVE GOT BIGGEST FACT TO PRESENT TO SC, the Aadhaar data creation has been going on since 2011, and as per Government s Process mandatory requirement and core basis was to do the Aadhaar Enrolment after identify a person only with a person's properly signed application form, Proof of Identification and Proof of Address as legal and valid support.

APPLICATION FORM - Properly filled up mandatory application of resident

POI - Proof of Identity

POA - Proof of Address

POR - Proof of Relationship

Sending you valuable inputs about chaos of aadhar, which may become dangerous tool in hands of government, through UIDAI.

On superficial examination one feels , its good tool, but there is no doubt that the aadhaar is absurd and most dangerous tool, which may infringe privacy laws. In India, no one except SC is bothered about privacy aspects but its undoubtedly dangerous tool in hands of government.

It is proven beyond doubt that Since basic data of 45 Crore people itself is bogus [without any application form, supporting proof documents]. As a law teacher and lawyer working in my home system, but concerned with issues of law and technology that are global more than they are national, i've spent the last several years paying much more attention to the Indian Supreme Court. In cases involving decency regulation and intermediaries' liabilities for user-generated content, the Supreme Court has begun to frame a voice on issues involving political and expressive freedom in the age of the networked society.

It will be considering these questions as will the highest constitutional courts of the United States, the European Union and its members, South Africa, or post-European Britain. A powerful court speaking for the world's largest democracy on issues of privacy, expressive rights, surveillance, identity control and the other similar matters now coming to the fore in all societies will be immensely influential.

All of which leads me to regard with puzzlement the efforts the Supreme Court is apparently taking just now to avoid speaking at all on the most important of current questions, not just for India, but for humanity. The Supreme Court now has before it – pending already for a period of almost two years – petitions asking it to rule on whether Indian citizens have a constitutional right of privacy against government.

The case of Justice KS Puttaswamy & Others vs Union of India & Ors was the first in the series of cases challenging the Aadhaar scheme. The case, along with 15 other matters tagged along with it, is currently pending before the apex court, after being referred to the Constitution Bench in 2015.

The Court has ruled, and occasionally reaffirms in commentary on related matters, that Aadhaar registration cannot be made generally mandatory, yet it has before it unaddressed numerous petitions concerning large numbers of social services for which Aadhaar registration has been made mandatory in apparent contempt of the Court's ruling.

Taken together, these matters that the Supreme Court does not seem to want to hear ask the most important questions now pending anywhere among the societies that adhere to the rule of law, concerning citizens' freedom in 21st century societies. If government does not have a positive responsibility to protect the privacy of its citizens, including against itself, then the technologies of behaviour collection now being grafted into the nervous system of humanity we call the internet will make new, hyper-efficient modes of despotism inevitable.

If citizens don't have the right to inspect and understand biometric identification databases that contain all our identities and all the behaviour that is attributed to us, what we now think of as "free society" can be turned off at any time. The Indian

Supreme Court's docket now includes clear and pressing questions that lead to the heart of issues all the world's democracies are going to face very soon.

But two successive Chief Justices have now found it impossible to constitute a seven-member bench to hear the privacy right petitions. No action is being taken on the Aadhaar contempt petitions as the Government moves on. **The inertia is mysterious and surprising. The world is listening; the voice of India's constitutional lawyers reasoning for their powerful and immense society will speak directly to the judges of the rest of the world's democracies.**

In the US Supreme Court, where I had the privilege to work for Justice Thurgood Marshall as a young law clerk, there is a valuable assumption that everything on the docket at the start of each term will be resolved by its end. Perhaps once in a decade, the Court will order a re-argument of some matter, putting it over for a second yearly term.

The US Supreme Court, it is true, controls its docket and selects its cases differently than the Indian Supreme Court, and the presumption of an ability to dispose of everything within one year cannot be recommended here. But all our courts descend from those made in the England of King John's Magna Carta of the year 1215, in which it was first promised to observe the truth that justice delayed is justice denied.

For all of us throughout the human race who live under the rule of law, how the Indian Supreme Court decides the cases now pending before it will have important consequences. All the other developed democracies recognise some form of the constitutional right of privacy against government. If the Indian Supreme Court shows that the world's largest democracy believes it can survive without that commitment, it will weaken the cause of privacy throughout the few parts of the world that uphold it.

If, on the other hand, the Supreme Court places India in the vanguard of the constitutional democracies, then the evolution of Aadhaar, UPI, and other aspects of Digital India will occur in a legal and constitutional context that will become a light unto nations, an example to the world's advanced societies. What is the Supreme Court waiting for?

Observations :

- i. This world is full of darkest of clevers and morons. An average person or even a qualified person, who has superficial knowledge and understanding, thinks as if he has overall clear picture. The writer is extremely right in highlighting bitter fact of life that this tool is no doubt good one in our corrupt country like ours where every other fellow is crooked, corrupt, not bothered, prone to illegal means.

- viii. Wrong Aadhaars have been issued, I saw a person showing me two different aadhars having same photo and on portal both numbers are active [shocked ?],
- ix. A lady is denied of her pension as her criminal nephew has forged bio-metrics and claiming all pensions since past three years conniving with postal / bank clerks.
- x. Worst point now, UIDAI did this massive exercise, giving all critical powers to intermediate passed operators, who were supposed to verify all supporting documents. all processes are only in papers and in air of documents, but reality is that enrolment had been rampant to complete targets. Final nail in coffin, As on date UIDAI does not have more than 45% of application forms,

proof of Aadhaar supporting documents, which were mandatory part of basic enrolment activity, starting point.

- xi. Now tell me, how can any one become part of critical national data repository, without any head or tail, or supporting document as evidence. If today Supreme court demands UIDAI, proof of all individual s proof of supporting docs, UIDAI officials will leak in pants. It is as simple as that they dont have at all.
- xii. I know about a case, where crooked nephew got his enrolment done showing her aunt s face, and he is drawing money of pension in collusion with officials since years. So in a way, entire exercise is standing on quicksand. So let us all appreciate point of view and dont rush to a conclusion that all is well with Aadhaar.
- xiii. In a Uttarakhand village, entire village has same date of birth mentioned on aadhaar, all this happened due to erroneous system of Data capture by UIDAI. [There were no verifiers to check forms, which was a mandatory process.]

Corruption at UIDAI :

A. World's Most Technically organized Loot of Exchequer :

UIDAI has flouted all procurement rules, regulations and pushed entire process of Enrollment through unique and one of its kind model of outsourcing and notifying machinery to do aadhaar enrollment

- xiv. Pushing to the throat of Public, Bio-metrics without any large scale global precedence or technical trial benchmark or mechanism. Entire UIDAI was pushed as if it is simple routine data management exercise. **Rs. 10,000 Crores Wasted** without assessment of proven Bio-metric technology and silently trying to portray as if Bio-metrics is best.

India, a leading backward country is incorrectly trying to show to world that there are strong technical strength whereas, this kind of technology is not at all approved by Top level economies, due to inherent risks of accuracy.

Tomorrow suddenly someone will start telling that body - morpho analysis tool is designed to identify a person's face, so country cannot go ahead on flimsy grounds. There is no process to prove any such activity of Testing the Bio-metric technology.

- xv. UIDAI never placed direct order to buy mass-scale bio-metric devices and clandestinely pushed through recommendations route and Only Limited Machine types for Bio-metrics were recommended to be purchased by vendors at exorbitant prices. Many complaints were made but no result.

Companies bloated prices of machines and heavily charged from enrolment companies.

- xvi. Processes were in papers only and all over country, all kinds of jokers, grocery shops, restaurants, any type of business entity was happily allowed to do enrolment expecting that a business entity will even understand language of compliance of processes, technologies and systems of security.
- xvii. Any street johnny was allowed to do enrollment and merely passing a sitter blinder ridiculous exam was put to do eye-wash about standard of operators.
- xviii. Legal processes were never followed while doing enrolment for aadhaar. No application form was received before enrolment, no control was made to make sure retention of application form, supporting documents of each individual person prior to doing data capture of aadhaar enrolment.
- xix. There is no way, a semi-literate operator will not compromise on quality of data capture [A person got his aunt's name, photo and intentionally put his bio-metrics, and got aadhaar number; After getting aadhaar number he kept on receiving money in his bank account which he had opened in name of his aunt.] It is aadhaar based impersonation. There might be thousands of similar cases. But aadhaar is silent about all such gaffes and compromises.
- xx. **Poor data quality** of residents is very common, where authentication fails from UIDAI matching systems. Can UIDAI face live enquiry in front of SC to 100% match even 300 persons bio-metrics? answer is No as, in rural india, 30% people get failed aadhaar authentications. Why?
- xxi. UIDAI knows already but remained ignorant of the fact that lakhs of aadhaar enrolments were made from abroad [Nepal, Lanka, Bangladesh, Dubai and may be Pakistan also]. Its crime to contain any such data for a person who got his aadhaar made based on photo-copied documents. Sick Now when 115 Crores of records got generated, they have done eye-washing thru costly GPS tracker devices at centers.
- xxii. UIDAI remained sleeping about record generation without any supporting document and now out of 115 crore residents, 95% residents have been issued without any verifier. Verifier was in papers only as per provision but hardly 5% data was generated by using Verifier's role. UIDAI will never be able to prove this fact that 95% records were accepted by them without any kind of signature of verifier [mandatory role was to check docs for content and physically match person].
- xxiii. Lately from 2017 onwards UIDAI after completing 95% of enrollment through private and unregulated agencies, suddenly realized that there are corruptions at enrolment centers and tried to cover-up blunders and just to appease Supreme Court, moved machines to Government premises and Banks, panchayats [whereas everyone knows what kind of corruptions are happening in Municipal offices, panchayats being centers of all kinds of palm-greasing happening day and night.]
- xxiv. If decoy checks are done, even UIDAI officials are taking bribes to start a machine or allow a machine or disallow a machine for UID Enrollment [Rs

5000 to 10000] are taken by UIDAI middle manager ranked officials responsible to do so called on-boarding process as a favor and they indulge in allowing scrupulous operators to run their machines and they keep blind eyes against such robbers.

- xxv. UIDAI has double standards, they have closed eyes to corruption happening at CSC agents [so called government body] and UIDAI have disallowed all other private organizations, reasons best known to them, just to do convey to SC that there are no private companies as of now, as eye-wash .
- xxvi. Whatever is being said by UIDAI is just cover-up exercise as those criminals know, that if such a massive induction of bogus data appears open to public, they will be lynched and project will get scrapped.
- xxvii. After 95% of enrolment completion, now UIDAI woken up suddenly and realized blunder of not using GPS devices [to track GPS position of machines] as many aadhaars were done outside India.

As recent as July 2017, UIDAI clandestinely recommended purchase of GPS devices from 3-4 unknown and non-registered companies who did not have even registered offices or sales tax number registrations, therefore it is clear that CEO – UIDAI was involved in tacit support of all these croons who exorbitantly charged from more than 2 lakh uid operating agents.

A piece of GPS device comes in market for rs 500 only whereas those permitted robbers have sold at Rs 3500 per unit so direct corruption of Rs 3000 x 2 Lakhs = 7000 lakhs [**Seventy Crores Scam**] There must be proper enquiry of this and CEO and others who are pack of hounds at UIDAI , must go to jail till death.

- xxviii. People were fleeced to get aadhaar numbers by paying Rs 100 to Rs 1000 per aadhaar due to stupidity of UIDAI , so let us multiply appx 50 Crores x Rs 100 = Minimum of **Rs 5000 Crores of corruption**. Who will repay such a money to innocent and Poor citizens who had to spend hours in line. This happened due to inefficiency of UIDAI s system and approach to capture data.
- xxix. There is zero support from UIDAI, There are many cases who are running from pillar to post to get their aadhaar number issue solved due to one or other problem. They are sitting in secured well where no one can access or raise their plight. UIDAI junior management people are all taking bribes to do registration of Aadhaar centers and charge rs 5000 per operator.

Final Humble Prayer :

In the best interest of our country, my humble prayer to Honorable CJI and all the learned judiciary that please! please go through my statements, immediately stop and burry this UIDAI s Aadhaar menace, order a proper enquiry and audit process through some empowered multi-source judiciary, technical and administrative committee and destroy all such forces who are stealthily trying to hold on to dangerous tool which has definite dimensions of gross misuse coz, the aadhaar data itself is bogus [45 Crore records]. PLEASE NEVER LISTEN ANY EXCUSE OF BUYING TIME OR PUSHING FURTHER CONFUSING WORDS FROM UIDAI OR GOI.

If something is prone or subjective to particular action or safeguard measure, it cannot be allowed. It is something like you allow a murderer to keep revolver and expect him not to use on his wish.

Moreover, Aadhaar system itself is full of bogus data, where there is no basis to accept request for Aadhaar without any application form, and to generate Aadhaar without any proof of supporting document. 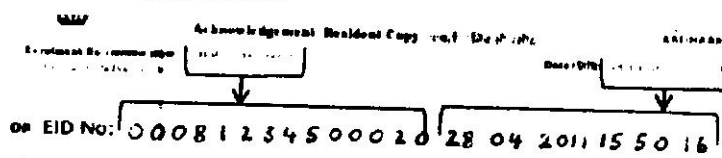
